**TWO WOMEN ASSIST AN ICE AGENT HAVING A MEDICAL EMERGENCY AFTER
HE AND MULTIPLE OTHER ICE AGENTS WRONGFULLY ARREST AND
CRIMINALLY CITE THEM**

On Thursday January 22nd, two Brooklyn Park residents, Tiffany Amundson and Heather Zemien, were ambushed and forced out of their vehicle by ICE agents just after they were talking to a Brooklyn Park Police Officer, as shown in the video below which was taken by a Brooklyn Park Police Department dash camera. Ms. Amundson and Ms. Zemien have since received criminal citations from federal authorities. The video clearly shows no criminal activity, they pull in front of the police vehicle to allow ICE agents that were behind them to pass, but instead of passing them, ICE agents, many of whom were masked, and not clearly identified as law enforcement, surround their car and force them out. The actions of ICE not only violate the United States Constitution, but also any sense of common decency. They are the actions of a police state, not a free country. The citizens of our state are being terrorized by an out of control federal government, which has already killed two people in Minnesota, and abused countless others.

After their arrest, while Ms. Amundson and Ms. Zemien were being taken to a federal detention center, one of the ICE agents who had been involved in arresting them had a medical emergency that appeared to be a seizure. Ms. Amundson and Ms. Zemien assisted in providing care and comfort to the man who had been involved in wrongfully arresting them until an ambulance arrived.

Ms. Amundson and Ms. Zemien will continue to stand up for their right, and the right of everyone, to be present in their community and express their opposition to the criminal actions of ICE and the current federal government.
