**Federal Civil Rights Case Against City of Edina Advances as Evidence Raises Serious Concerns About Officer and Paramedic Conduct**

The federal civil rights lawsuit *Kyle Moore v. City of Edina, et al.* continues to move forward after being filed in April 2024. More than six years have passed since the October 6, 2019 incident, and significant questions concerning the actions of responding officers and paramedics remain unresolved. To date, none of the individuals involved have acknowledged responsibility for their roles, have not faced any consequences for their involvement, and no corrective action has been taken.

The available evidence paints a troubling picture. Surveillance video from the scene, along with information contained in the defendants' own reports, reflects a sequence of events that diverges sharply from later explanations. These inconsistencies have heightened the importance of a full and transparent examination of the facts in federal court.

Mr. Moore continues to live with the lasting physical, psychological, and emotional effects of the incident. His recovery has been lengthy and difficult. The absence of accountability and clarity surrounding this incident and its effects has only intensified the hardship he faces on a daily basis.

The City of Edina has denied responsibility. However, several of its stated positions conflict with objective evidence and the statements of its own personnel. These contradictions underscore why independent judicial review is essential and why this case carries significance beyond Mr. Moore's individual experience.

The lawsuit seeks to provide Mr. Moore the resources necessary to obtain needed medical care and regain stability in his life. It also aims to ensure that future encounters between public-safety personnel and citizens in crisis are guided by accurate assessments, appropriate tactics, and sound professional judgment. The issues raised in this case are not abstract. They concern the expectations the public places in those sworn to serve and protect, and whether those expectations were met.

Counsel for Mr. Moore looks forward to presenting the full evidentiary record at trial. The goal is straightforward: clarity, accountability, and a path forward that prevents similar outcomes for others.
